Use of the manual

It is very important that this manual, designed to provide the operator with a general knowledge of this machine as well as with the instructions for its use and maintenance deemed necessary for with functioning, is kept the machine for any future reference. proper The manual, as specified by law, is part of the machine and must accompany it to its demolition. The warnings given must be read carefully, for safety reasons, before installation and before use. It is prohibited for any reason to modify this manual without written permission of the manufacturer or authorized dealer.

General safety warnings

- The machine is built on purpose. Its durability and reliability will be much more effective if it is correctly used and regular maintenance will be done.

- Always read the warnings contained in this manual, they provide important information on safety.

ATTENTION!

- The use of the machine should only be performed by adequately trained personnel of full age, in full compliance with current regulations and with the instructions contained in this manual.
- Strictly follow the directions and mandatory and danger signs on the machine.
- Before any maintenance, electrically isolate the machine to prevent accidental starting.
- In case of injury or breakage of the connecting pipes or electrical cables, act quickly to replace them.
- If the equipment loses fluids, must immediately eliminate the loss.
- Do not leave the equipment exposed to weathering.
- Do not leave equipment unattended in the hands of children.
- Whenever you decide to stop using the equipment, you should make it ineffective in fulfilling all practices regarding the disposal according to law.

This machine will be used only for the purposes it has been designed, namely: to generate heat in ferrous materials.

Any other use not specifically covered in this manual is strictly forbidden, as improper and therefore dangerous. The machine is semiautomatic and requires the presence of the operator.

ATTENTION!


The operator has the responsibility for complying all the rules that relate to safety, not only for himself, but also those who may be exposed to the risks of the machine. Therefore, before performing any operation with the machine, read this manual carefully, it shows the instructions and how to proceed properly and safely. Keep this manual for future reference.

Use of the machine

Turn on the main switch on the left side and the machine will be already functional and operating



Pressing the button of Fig. 4 for 10 seconds, all the LEDs remain off. Then the LED indicators of the power will come on and then you can operate. This delay is necessary to allow the cooling liquid to enter fully into circulation. If there are flashing LEDs alert the 1-2-3 keys, press the reset button (4) and wait a few seconds. If the problem persists, contact the dealer after sales service.

Construction Features

The machine was designed and constructed in compliance with the essential safety and health requirements according to the Machinery Directive 89/392 EEC and subsequent amendments. In particular, since the operator is in direct contact with the machine, the manufacturer provided the machine with:

Eliminate sharp edges and angular;


Avoid unstable conditions that can cause risk of overturning, falling or moving inappropriate; Do not allow the operator to come into direct contact with live parts during working that can result in electric shock or injury.

And everything else needed to make the use of the machine safe.

The <u>main parts</u> composing INDUCTOR FIRE F110 can be

described as follows:

- 1) Power switch
- 2) Control panel
- 3) Inductor
- 4) Electronic card
- 5) Refrigerator
- 6) Cooling Group



Plates and warnings signs

On the machine are placed warning signs and mandatory signs that the operator must follow for his safety and security.

List of protections

The machine is safe if used correctly, however, should be as careful as heated material may cause burns to the touch even long after the passage of the inductor. The inductor itself also becomes hot, even if continuously cooled, by contact of red-hot parts and therefore can have risk of burns.



The machine has several electrical and thermal overload protections. The first protection is the "overload" inductor; to restart the machine, simply release the control and then press it again. For all other protections, switch the machine off with the general switch. Finally, there is a series of 32 A fuse on the incoming line, protection in case of failure of electronic protections. Do not replace these fuses before repairing the fault.

RESIDUAL HAZARDS

WARNING!

The machine is designed for maximum safety. However, there is the possibility that the operator, carelessly, can get burned.

WARNING!

The machine must not be used near sensitive or hazardous materials, explosives, compressed gases, flammable liquids, electrical medical equipment.

It is not allowed to use this machine while wearing metal objects because they heat in the vicinity of the inductor.

It is not allowed to use this machine if the operator has a cardiac pacemaker or other biomechanical implant.

Noise and vibration

The machine produces a sound pressure level for continuous use of less than 60dB (A). The machine does not generate vibrations that can cause consequent danger.

Demolition and disposal

Some materials, with which the machine is built, can be recycled, so do the demolition and recycling, in accordance with existing regulations.

Unpacking and Installation

The machine is supplied ready for use.

Before using it, you must remove all packing material and place it carefully in place (leveled floor, dry and windy).

WARNING!

The installation must be designed to allow easy access to all its parts. The minimum spaces, on its perimeter, must ensure the use and maintenance, without problems and risks for the operator.

Connection

The voltage and frequency must match the nameplate data. The machine is supplied complete with wiring, so you just plug it in a suitable socket. WARNING!

Connect the plug only to a socket provided with lifesaving.

Use of the machine

Turn on the main switch, turn on the machine, wait 10 seconds for the test red light turns off and then adjust the power as needed.

Place the inductor on the part to be heated, giving power through the button on the handle, then move the inductor as needed.

When finish to use the machine, leave the machine turned on a few minutes to give way to the machine to cool.

Replacement of the flow concentrator

In case of the flow concentrator wear, unfasten the screw, take off the ferrite, thoroughly clean the copper and replace the new piece fastening the stainless steel part very firmly.

Replacement of the Inductor

WARNING!

The replacement of the inductor should be performed by authorized staff only and only after turning off power to the machine. We recommend thorough cleaning of the contacts and accurate tightening.

WARNING!

During the maintenance and / or repairing operations, wear protective gloves.

• Isolate electrically the machine disconnecting it from the power supply.

WARNING!

It is prohibited to start the machine unless all protections are installed.

Maintenance – general rules

- It is essential that interventions on the machine are carried out by qualified and authorized personnel to be aware of the mode of maintenance.
- Never perform any cleaning, lubrication or maintenance operation with the machine running.

• Before any maintenance, position the main power switch to "0" to disconnect power,

unplug it from the network to avoid electrical shock or other hazards from mishandling.Do not wear rings, watches, jewelry, clothing undone or dangling, such as ties, torn clothing, scarves, jackets unbuttoned and zipped open that can get caught at work.

• It is recommended instead to use garments suitable for accident prevention, for example: sturdy shoes, deadening headphones, safety glasses, appropriate gloves, etc ...

• Never use gasoline or flammable solvents to clean the machine. Use water and, if necessary, commercial non-toxic solvents.

• After the interventions, before restarting the machine, always reassemble the protections that may have been removed.

Preventive maintenance

Meticulous inspections conducted at regular intervals of time are necessary in order to detect and eliminate faults quickly before they can cause more damage.

ATTENTION!

Whenever you need to use the INDUCTOR FIRE F110 previously control the efficiency of safety devices, connection status, or that there are not any other anomalies, making several test maneuvers idling and on ferrous scrap.
Check daily for wear and legibility of the warning signs.

Ordinary Maintenance

WARNING!

The safety operation of the machine can be guaranteed only if the repairs are performed using only original spare parts or other parts approved by the manufacturer and if maintenance instructions are carried out correctly.

• After each use, with the electric switch turned off, the operator must proceed with the cleaning of the machine, promptly removing dust or dirt in general, because it could decrease the aeration and also affect the smooth operation and durability of the machine.


• Before each use check the operation of control devices, safety devices and the integrity of electrical cables.

Carry out regular visual checks on the inductor to verify that there are no fluid leaks and on the air inlet ports to verify that they are free.



Table 1. Cabinet exploded viewTable 2. Electronic boardTable 3. Hydraulic exploded view




